## **SECTION 4) FIRST-AID MEASURES**

### Inhalation

Eliminate all ignition sources if safe to do so. Remove source of exposure or move person to fresh air and keep comfortable for breathing. Call a POISON CENTER/doctor. If breathing has stopped, trained personnel should begin rescue breathing or, if the heart has stopped, immediately start cardiopulmonary resuscitation (CPR) or automated external defibrillation (AED). ### **Skin Contact**

Take off contaminated clothing, shoes and leather goods (e.g. watchbands, belts). Wash with plenty of lukewarm, gently flowing water for

#### **Eye Contact**

## **SECTION 5) FIRE-FIGHTING MEASURES**

## **Suitable Extinguishing Media**

Dry chemical, foam, carbon dioxide water spray or fog is recommended. Carbon dioxide can displace oxygen. Use caution when applying carbon dioxide in confined spaces. Simultaneous use of foam and water on the same surface is to be avoided as water destroys the foam. Sand or earth may be used for small fires only.

### **Unsuitable Extinguishing Media**

Do not use water jets.

### **Specific Hazards in Case of Fire**

Can form explosive air mixtures.

Containers can explode in a fire. Highly flammable with toxic fumes. Give off toxic fumes at high temperatures.

Vapors are heavier than air and may settle in low places or spread a long distance to source of ignition and flash back.

### **Fire-Fighting Procedures**

Isolate immediate hazard area and keep unauthorized personnel out. Stop spill/release if it can be done safely. Move undamaged containers from immediate hazard area if it can be done safely. ## **SECTION 6) ACCIDENTAL RELEASE MEASURES**

### **Emergency Procedure**

## **SECTION 7) HANDLING AND STORAGE**

### **General**

### **Eye Protection**

### **Skin Protection**

Use of an apron and over- boots of chemically impervious materials such as neoprene or nitrile rubber is recommended to avoid skin sensitization. The type of protective equipment must be selected according to the concentration and amount of the dangerous substance at the specific workplace. Launder soiled clothes or properly disposed of contaminated material, which cannot be decontaminated.

### **Respiratory Protection**
